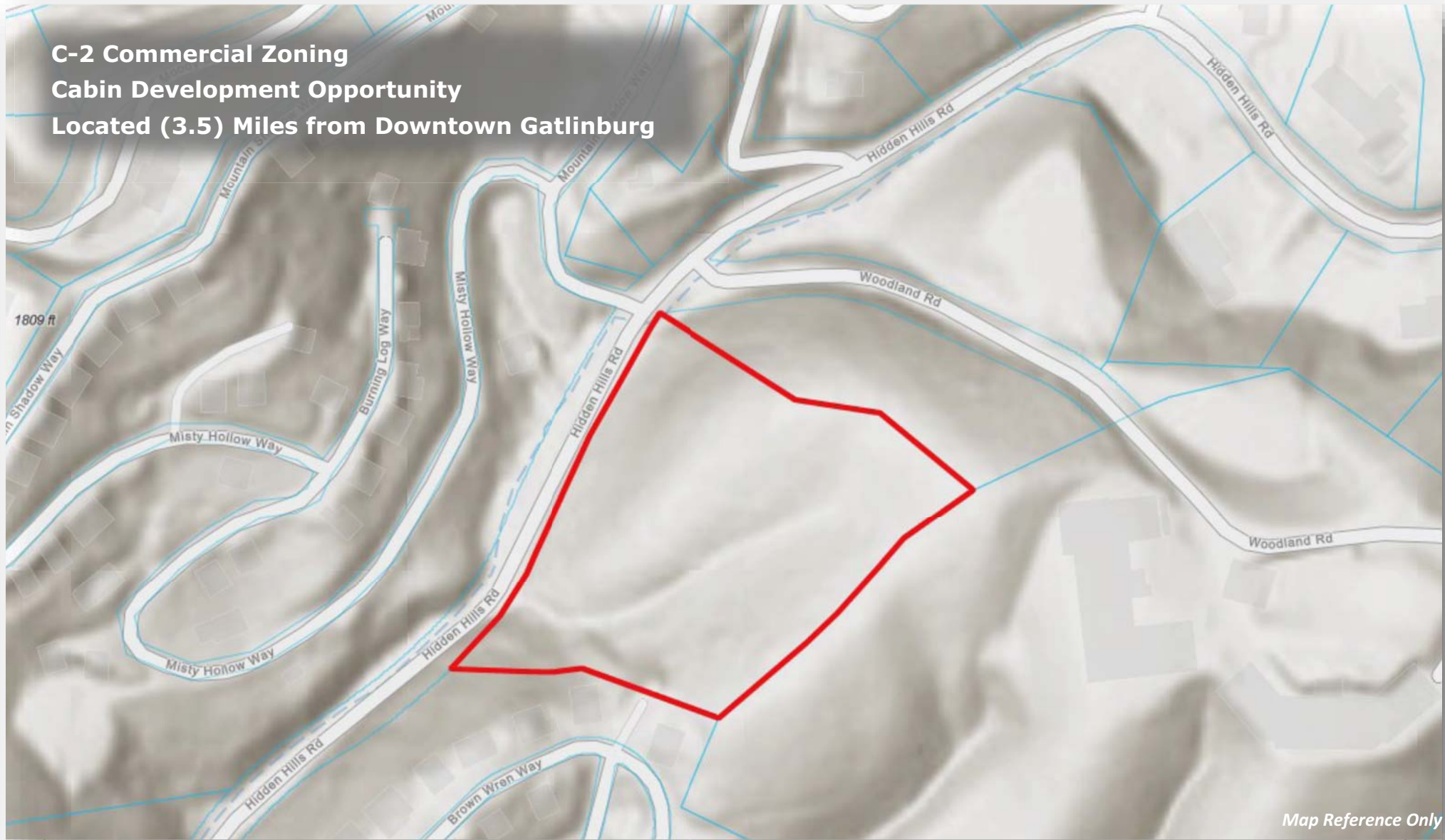


**C-2 Commercial Zoning

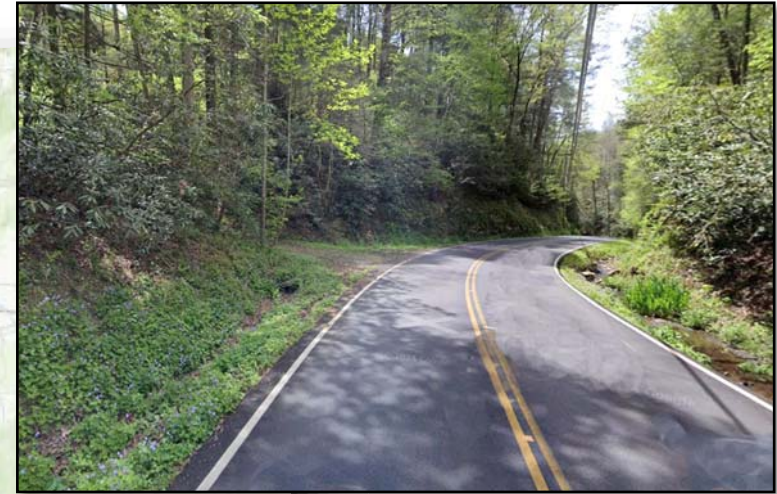
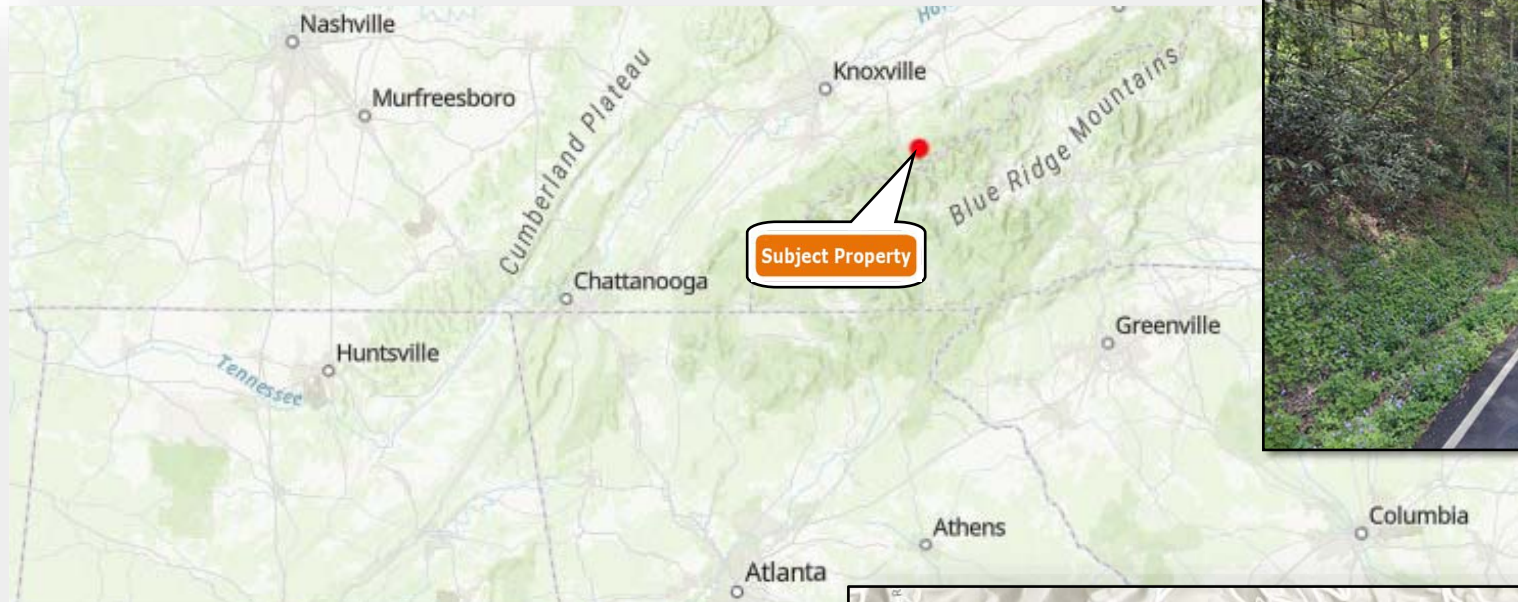

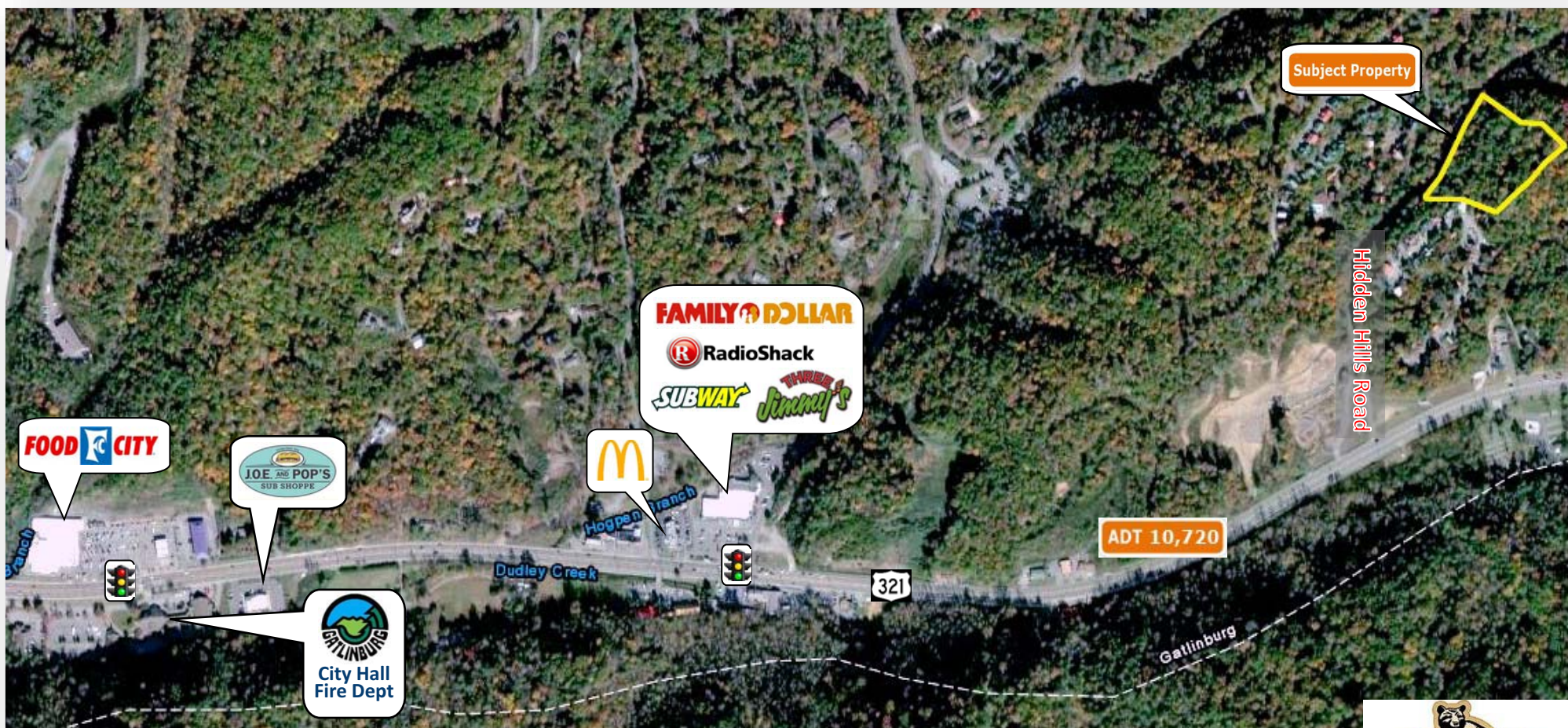
