

Campground Information and Rules

Lake California RV Park and Campground is a Private Recreational Facility provided and Maintained by The Lake California Property Owners Association (LCPOA)

QUIET TIME HOURS – From 10:00 P.M. to 7:00 A.M. any noise that disturbs your neighbor is not allowed.
REGISTRATION IS REQUIRED 3 DAYS PRIOR TO ARRIVAL

PLEASE! DO NOT ABUSE CAMPING PRIVILEGES BY OVER CROWDING ONE CAMPSITE. ALL CAMPING IS AT INDIVIDUALS OWN RISK; THE LCPOA ACCEPTS NO LIABILITY FOR INJURY OR DAMAGE.

USE OF THIS FACILITY IS A PRIVILEGE NOT A RIGHT

Tent camping by **Property Owners** is limited to a maximum of **4 Spaces** per lot (including guests). All **Property Owners** having tent camping guests must be present in **Lake California** during the full term of their **guests'** stay.

ARRIVAL - Proceed to the campground where the Campground Host will direct you to the proper section and space. Check in time is **10:00 A.M. to 9:00 P.M.** **All fees will be collected at that time.** Check out time is **2:00 p.m.** Number of sites cannot be increased at the time of arrival and any number in excess of original reservation may not be allowed in. **Maximum 20-day camping limit. After a 10-day absence, you may be our guest again for another 20-day period of time. NO REFUNDS FOR EARLY DEPARTURE.**

VEHICLES - All vehicles must be street legal and currently licensed by the State of California. Only one vehicle, in addition to the RV, is allowed per space. The Campground Host will decide the location for parking any "extra" vehicles and issue permits indicating that location.

MOTORCYCLES and other recreation vehicles - May be used on paved streets only. **NO** off-road travel is permitted. Only those vehicles, which are street licensed by a State licensing authority, may be operated on our streets.

TENT CAMPING - Each family's vehicle entering the park must rent their own space. 1 large tent and 1 small tent only will be permitted per space. 6 person maximum per space.

RESTROOMS - Out of respect for other campers, group activities must not be concentrated around restroom and shower facilities.

PETS - Pets must be kept on a leash **at all times** whenever outside and must not be left unattended while tethered. Animals may not run loose. All excrement must be picked up immediately, bagged and disposed of in a dumpster. Frequent or continual barking or baying will not be tolerated. Limit of two pets will be enforced. Non-licensed dogs are not permitted due to high incidence of rabies in this area. **NO PETS ALLOWED IN TENT CAMPING AREA except for service dogs (please bring proper documentation).**

FISHING - No fishing is allowed in the ponds or lakes unless you are in the company of a property owner **at all times.** A valid California Fishing license is required.

FIREARMS - Firearms, air-guns, BB guns, sling shots, bow and arrows are forbidden.

CAMPFIRES - Are not allowed. Fireworks are strictly FORBIDDEN.

COMMERCIAL ACTIVITIES - Any commercial activity or illegal activity is not permitted in the park.

WATERBALLOONS – Are **NOT** allowed.
